Trustee, Gareau made motion to approve the financial report with transfers. Theresa C second. All in favor. Motion passed.

Supervisor Rymkos received a letter from the Gladstone Library acknowledging appreciation for the amounts they received from area townships and the City of Gladstone.

Pumper Truck needs repairs. Repair estimate has been requested from CSI of Grayling, MI Replacement cost is between \$750,000 -\$800,000. Grass truck replacement cost approx. \$130,000.

Trustee Gareau made motion to close Budget Hearing at 8:45 pm and re-open and resume regular meeting at 8:45 pm. Treasurer Kanuf-Wycoff second. All in favor. Motion passed

Supervisor Rymkos announced Dan Marenger applied for the Cemetery Sexton position. Treasurer Knauf-Wycoff made motion to appoint Marenger as Cemetery Sexton. Second by Trustee Gareau. All in favor. Motion passed

Clerk Chenier made motion to post the Planning Commission "Draft" Solar Ordinance on the website. Second by Treasurer Knauf-Wycoff. All in favor. Motion passed.

The Future Land Use Map was reviewed. Clerk Chenier made motion to approve the Planning Commission's presentation of the Future Land Use Map. Trustee Gareau second. All in favor. Motion passed.

Motion made by Trustee Gareau with second by Treasurer Knauf-Wycoff to approve Supervisor Tom Rymkos to sign property purchase title documents as agent for Escanaba Township. All in favor. Motion passed.

Supervisor Rymkos announced the Board is still looking for a member. Ad was placed in paper but no response yet. Planning Commission also needs 2 members. Trustee Gareau will talk with Ron Hughes to fill the temporary position.

Letterhead and business cards need to be ordered.

Treasurer Knauf-Wycoff made motion to approve payroll policy and record of hours. Second by Trustee Gareau. All in favor. **Motion passed.** Policy includes a pro-rated salary based on time worked during the month.

Clerk Chenier announced there is not a Liaison report for the Planning Commission. That meeting was cancelled due the fact of not having a quorum present. Cathy Culliton, Scott Knauf and Carla Beauchamp have all been sworn in for their new duties. It is a possibility the Planning Commission may become a 5 member board again.
